DUE TO THE NUMBER OF RESERVATIONS AND REQUESTS RECEIVED, NO RESERVATION IS FINAL UNTIL A REQUEST FORM AND DEPOSIT HAVE BEEN SUBMITTED AT LEAST TWENTY-FOUR (24) HOURS BEFORE THE RESERVATION DATE. RESERVATIONS ARE TAKEN ON A "FIRST COME – FIRST SERVE" BASIS.

#### **POOL BBQ PITS:**

BBQ PITS CAN BE RESERVED APRIL-SEPTEMBER BETWEEN THE HOURS OF 10:00 A.M. – 10:00 P.M. MONDAY, WEDNESDAY, THURSDAY, FRIDAY, SATURDAY AND SUNDAY. RESERVATIONS ALLOWED ON TUESDAY AFTER 5:00 P.M. ONLY, AS AREA IS CLOSED FOR WEEKLY CLEANING. OCTOBER-MARCH RESERVATIONS CAN BE MADE FROM 10:00 A.M.-4:00 P.M. SATURDAY & SUNDAY ONLY

### **MAXIMUM NUMBER OF PEOPLE:**

BBQ 1 = 50 PEOPLE BBQ 2, 3, 4, 5 = 25 PEOPLE CLUBHOUSE = 35 PEOPLE MAXIMUM TOTAL NUMBER OF PEOPLE FOR RESERVATIONS IS FIFTY (50). RESERVATIONS WITH TWENTY-FIVE OR MORE PEOPLE WILL NECESSITATE AN EXTRA GUARD WITH AN EXTRA CHARGE OF \$30.00, CHECK OR MONEY ORDER MADE PAYABLE TO WSC PROTECTION SERVICES.

# **CLUBHOUSE:**

SATURDAY & SUNDAY 10:00 A.M.-4:00 P.M. (OCTOBER – MARCH)

CRAFT/PRODUCT PARTIES AND/OR SHOWS FOR PROFIT ARE NOT ALLOWED.

### FEE IF RESERVATION IS OUTSIDE OF POOL MONITOR HOURS:

THERE IS A <u>\$25.00</u> FEE (PAYABLE TO RIVERLAKES RANCH MASTER ASSOCIATION AT THE TIME OF MAKING RESERVATION) IF SECURITY IS REQUIRED TO OPEN/CLOSE THE FACILITIES AND/OR TURN OFF / ON THE ALARM SYSTEM OUTSIDE OF NORMAL POOL MONITOR HOURS.

# **LONG TERM / ADVANCE RESERVATIONS OF THE BEACHCLUB:**

RESERVATIONS MAY BE MADE NO MORE THAN 30 DAYS IN ADVANCE FOR MULTIPLE DATES AS OPPOSED TO SPECIAL ONE-TIME EVENTS SUCH AS WEDDINGS. A MAXIMUM OF FIVE (5) CONSECUTIVE DATES MAY BE RESERVED. A SECURITY CHECK IN THE AMOUNT OF \$200.00 IS REQUIRED FOR EACH DATE AND FACILITY RESERVED AND MUST BE CLAIMED BY YOU AFTER THE FINAL INSPECTION HAS BEEN COMPLETE.

## **PROCEDURE:**

- SUBMIT COMPLETED RESERVATION REQUEST TO THE POOL MONITOR ON DUTY WITH A \$200.00 DEPOSIT. PLEASE NOTE THAT NO RESERVATIONS ARE ENTERED UNTIL THE COMPLETED REQUEST AND DEPOSITS HAVE BEEN RECEIVED.
- 2. DAY OF EVENT: THE POOL MONITOR OR PATROL OFFICER WILL BE PRESENT AND WILL BRING A COPY OF THE CONFIRMED RESERVATION. THEY WILL COMPLETE A CHECKLIST AT THE END OF THE EVENT. IF THE POOL MONITOR CONFIRMS THAT THERE IS NO REASON TO WITHHOLD THE DEPOSIT, THE POOL MONITOR WILL RETURN IT IMMEDIATELY.

#### **OWNER RESPONSIBILITY:**

I UNDERSTAND THAT I MUST FOLLOW THE RULES OF THE <u>RIVERLAKES RANCH MASTER ASSOCIATION</u> AND THAT MY GUESTS ARE MY RESPONSIBILITY.
